



- (viii) That the school shall admit the students as per the norms and guideline of the Directorate of Education.






- (ix) That the school shall not run any unauthorized classes or any other activity within the school premises and all the recognized classes shall run at one place in the premises of school without thoroughfare.

- (xvi) That the violation of any instruction/order/rule and regulation of the Department shall lead to the withdrawal of recognition of the school.


